Job Description

The EMERGE Listening, Inspiring, & Guiding Healthy Transitions (LIGHT) Program is an Early Treatment Program (ETP), and has a team-based, multi-element approach to treating transition-aged youth and young adults, ages 16 to 30, with First Episode Psychosis (FEP).

The candidate will provide educational and vocational support to youth and young adults (males and females, ages 16-30), in school and home settings, who are being served by the EMERGE program and experiencing their first episode of psychosis. The candidate will complete all necessary documentation in a strength-based manner per Wraparound DBHDD/Agency requirements and will actively participate in the development and implementation of the Plan of Care and Crisis Plan. The candidate will be expected to attend in-services and participate in staffing, weekly, and monthly meetings / consultations. The candidate will have to transport individuals in an agency vehicle, or in his/her personal vehicle.

Minimum Qualifications:

A Bachelor's Degree in Social Work, Psychology, Sociology, Mental Health, Counseling, or a related discipline -OR- High School Diploma with 3-5 years' experience in behavioral health. *The Bachelor's degree must be in the previously mentioned fields to be MHC eligible*. Must have a valid driver's license, and a clean driving record. Must be a self-starter, with excellent customer service skills,

Preferred Qualifications:

The selected applicant must furnish the required documentation authorizing work in the United States as well as pass a criminal background investigation and drug screening.
