Job Description

Medication-Assisted Treatment (MAT) is used to treat substance use disorders, as well as sustain recovery and prevent overdose.

The selected candidate will operate in the following areas: **Peer Support, Crisis Intervention, Treatment Planning, Advocacy, Documentation & Reporting, Education & Outreach**, and will collaborate with a multidisciplinary team, including mental health professionals, to ensure holistic care for clients. The candidate will attend team meetings and case conferences to contribute a peer perspective to the overall care plan. The candidate will offer empathetic and non-judgmental peer support to individuals dealing with mental health/substance abuse issues, and will share personal experiences to inspire hope, foster connection and promote a sense of community among clients. The candidate will assist in crisis situations and collaborate with mental health professionals to develop and implement individualized treatment plans. In addition, will advocate for clients' right and needs within the healthcare system and community. Also, the candidate will maintain accurate and confidential records of client interactions and progress, and will conduct educational sessions for clients, families, and community members to raise awareness about mental health issues and reduce stigma. The candidate will also participate in outreach activities to connect with individuals who may benefit from peer support services. *Position is Mon-Fri, 8am to 5pm, working with men and women peers, who are 18 years of age or older.*

Minimum Qualifications:

High school diploma/GED with experience working with individuals with addictive diseases or mental health disorders. Additional education or training in social services is a plus. Must be willing to become CARES/CPS certified within one year. **Must have a valid driver's license & a clean MVR, as this position transports.**

Preferred Qualifications:

Bachelor's degree in social science or human services field. Previous experience as a peer support specialist and/or experience as a case manager. Previous experience working with individuals with mental health disorders and/or addictive diseases.
