## Job Description

**Medication-Assisted Treatment (MAT) is used to treat substance use disorders, as well as sustain recovery and prevent overdose.**

The selected candidate will: Receive & follow up on referrals; Make appointments for intake; After intake, complete referral to New Horizons Behavioral Health MAT-SOR Program; Complete MAT SOR Program Rx Payment Voucher West Central Health District (WCHD) & Medication Pharmacy Grant Rx Payment Voucher to Genoa Healthcare; Complete DHP Authorization for Release of Protected Health Information (PHI); Complete Midtown Recovery Release of PHI; Contact MAT individuals weekly with documentation into WITS system; Assist with any needs for MAT, Dr. appointments, getting medication, and assistance with getting to treatment; Coordinate with provider and nurse to address any concerns they may have; Attend meetings for MAT to update on progress; Procure and sign-out Narcan; Conduct evidence-based group with individuals who have been identified with a substance abuse disorder; Document daily notes on progress in groups & provide resources in the surrounding community that aid in maintaining sobriety; Aid in increasing coping & basic living skills. Other duties as assigned.

Position is Mon-Fri, up to 29 hours a week, and will serve adults in the following counties: Clay, Chattahoochee, Harris, Muscogee, Quitman, Randolph, Stewart & Talbot.

### Minimum Qualifications:

Bachelor's Degree in the human service field (i.e.: Counseling, Psychology, Social Work, Sociology, etc.). Must have experience working with individuals with mental health disorders and/or addictive diseases.

### Preferred Qualifications:

The selected applicant must furnish the required documentation authorizing work in the United States as well as pass a criminal background investigation and drug screening.
