## **Job Description**

Provide support and psychoeducation to individuals with outpatient treatment orders. Build supportive relationships with individuals in the program. Assist individuals in remembering and attending appointments, obtaining healthcare and other needed services. Assist them in obtaining housing, transportation, or meeting other basic needs. Assist with returning to school, obtaining/maintaining employment, based upon the individual's goals. Advocate for individuals when needed with the court or with providers. Provide encouragement and empower individuals to work toward their life goals. Report to treatment team and probate court regarding the individual's wellbeing and needs. Document and bill (as appropriate) services provided. Complete all required training.

#### **Minimum Qualifications:**

Be 21 years of age (valid Georgia ID); and • Have a mental health (MH) condition, substance use disorder (SUD), or a co-occurring diagnosis; and a strong desire to identify themselves as a person living with a mental illness or substance use diagnosis; and • Be able/willing to actively seek and manage your own appropriate care; and • Be able to share their own personal story in a safe and appropriate way; • Must be well grounded in recovery wellness • One year between diagnosis and application to training • If the individual has a substance use condition, there must be one year continuous abstinent from substance use • Have a high school diploma or GED; provide a copy of these documents.

Forensic Certified Peer Specialist

Applicants will be subjected to a Fingerprint Based Background Check of the Georgia and Federal Criminal History Record Databases.
