## Job Description

Under broad supervision, The Rural Care Coordinator will develop and expand relationships with law enforcement, the Courts, Primary Care Physicians, and other community partners to reduce the morbidity and mortality of substance use disorder (SUD), including opioid use disorder (OUD), in high-risk rural communities. RCC will work to ensure rural services are evidence-based and care is integrated and coordinated. RCC may provide SUD groups and other treatment services. RCC will work with recently incarcerated individuals in the rural area to link them to care, reentry services, and ensure individuals served by law enforcement and the Courts are referred to services as needed. RCC will complete required program reports for Morehouse School of Medicine. Candidate must have a valid driver's license and current car insurance and must be willing to travel within the eight (8) county area. Agency vehicle available.

### Minimum Qualifications:

Master's Level Licensed Individual. Must possess a valid Georgia driver's license.

### Preferred Qualifications:

Experience with Substance Use Disorder Treatment, especially Opioid Use Disorders.

The selected applicant must furnish the required documentation authorizing work in the United States as well as pass a criminal background investigation and drug screening.
